Subject: Island Hospital Position Statement

Island Hospital will work to achieve a 100% vaccinated workforce to help protect our patients, our community and our staff working conditions. Our healthcare system has an obligation to provide conditions that are safe to receive and deliver patient care. This focus to provide safe patient care and work conditions stems from our commitment to prevent harm.

Since July 2021, approximately 60 medical groups, have endorsed mandatory, universal vaccination of all public and private health care and long-term care workers, noting that such a requirement is the “fulfillment of the ethical commitment of all health care workers to put patients as well as residents of long-term care facilities first and take all steps necessary to ensure their health and well-being.” These organizations include:

Together with our Washington State Hospital Association (WSHA), the Washington State Nurses Association (WSNA) and Service Employees International Union (SEIU), Island Hospital supports the governor’s vaccine mandate proclamation for the need for healthcare workers to be vaccinated.

Within recent CDC studies, unvaccinated people are about 29 times more likely to be hospitalized with Covid-19 than those who are fully vaccinated. In addition, unvaccinated people were nearly five times more likely to be infected with Covid than vaccinated people. The Delta variant of COVID-19 is causing surges in cases across the United States and, because vaccination coverage is uneven within the states, there is higher transmission. New COVID-19 cases and hospitalizations continue to be largely limited to the unvaccinated, and only a small percentage of vaccinated people experience breakthrough infections.


As of September 10, 2021, the overwhelming majority of the 788 employed staff and 198 privileged providers of Island Hospital has committed to protect themselves, our patients and one another. Covid-19 vaccinations save lives, helps prevents severe illness and hospitalizations and lowers your risk of death.

Together with over 200 state and national healthcare systems including many with multiple hospitals, Island Hospital is committed to a timelined immunization of 100% staff and provider vaccination requirement as a condition of employment by October 18. Exemption and accommodations will be considered upon submission of a Medical Disability or Religious Based exemption written request. **Please note that approval of exemption request does not guarantee an accommodation can be offered nor does it guarantee continued employment.**
